#### I. Minutes of November, 2016 retreat

II. Treasurer's Report:

Michael Roman reported a net income for 2016 in the amount of \$88,513.50. Total expenses for 2016 were \$77,242.95 leaving a current balance of **\$51, 103.77**

The final payments for the 2016 retreat have been made and a deposit made for the 2017 retreat. The Annual Report was filed with Secretary of State. The address for the registered agent was changed to the location in Elgin, Illinois. In addition, the insurance payment for the board of directors has been made.

A telephone conference with the Illinois Department of Revenue regarding the tax exempt issue is scheduled for February 14m 2017 at 10am.

Regarding financial policies for the position of treasurer, the proposed policy will be sent to the board members for input.

III. Reports from Committees

A. Conference Committee:

There are still a few people that have not paid. Michelle Rock is continuing to pursue payment. The location and the date of the 2017 conference have been set. Further discussion was had about extending the length of the conference.

B. Technology Committee:

The ILAPSC conference "app" and electronic evaluations were discussed.

C. Government Committee:

In addition to the loss of services for consumers, Hugh Brady discussed the dire situation for treatment providers if the Medicaid provisions in the ACA are eliminated.

D. Public Awareness

The committee decided against the greeting card fundraiser.
