THE COMMITTEE



- Created April 2010
- 22 judges named as members
- Original charges: strategic planning, education and training of PSC judges, effective use of resources
- Expanded charge in March 2013 – develop PSC Standards and Certification process
- Charges in Civil Commitment

STANDARDS



- Form Working Group (May 2013)
- Study Standards from 11 states and NADCP Best Practice Standards (June-December 2013)
- Writing the Illinois PSC Standards – 30 drafts (January 2014-August 2015)
- Review by Chief Judges – August 2015
- Adopted by Supreme Court – Nov 2015

- Team input
- Sanctions, Incentives and Therapeutic adjustments

- Individualized
- Evidence-based; manualized
- Dosage and duration

Illinois Adult Risk Assessment (ARA)



- Created by the University of Cincinnati Corrections Institute as the Ohio Risk Assessment System (ORAS)
- Fourth generation actuarial assessment
- Suite of tools- allowing criminal justice practitioners to assess clients at various points

Illinois Adult Risk Assessment (ARA)



- UCCI established continued quality improvement and parameters for fidelity
 - Certification Process
 - Standardized data points to ensure accurate information
- Opportunity for validation
 - Currently validated within other states

ARA- Community Supervision Tool (CST)



- Utilized at time of disposition
 - Aids in disposition decision
 - Determines risk level/level of supervision of client
 - Shows what areas are driving the clients' risk level
 - ✦ Helps officers prioritize treatment/programming needs
- Components of the CST
 - File Review
 - Self-Report Questionnaire
 - Interview
 - Collateral

ARA-CST



- **Domains**
 - Criminal History
 - Education, Employment and Finances
 - Family and Social Support
 - Neighborhood Problems
 - Substance Use
 - Peer Associations
 - Criminal Attitudes and Behavioral Problems
- 35 questions in total disseminated throughout 7 domains

ARA- CST



Risk Levels

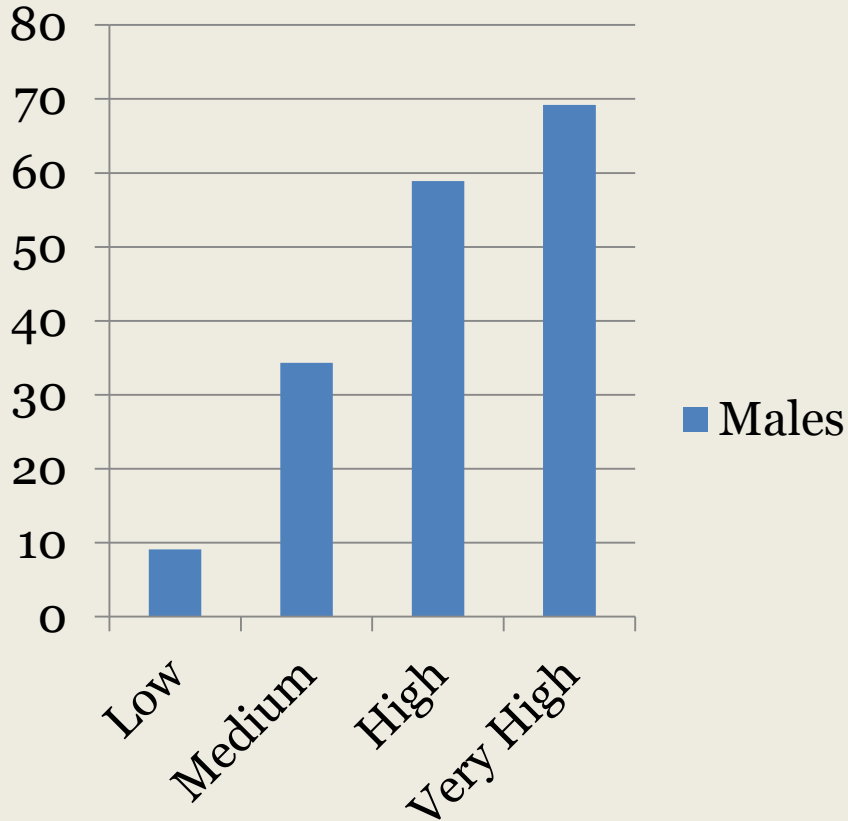
MALES		FEMALES

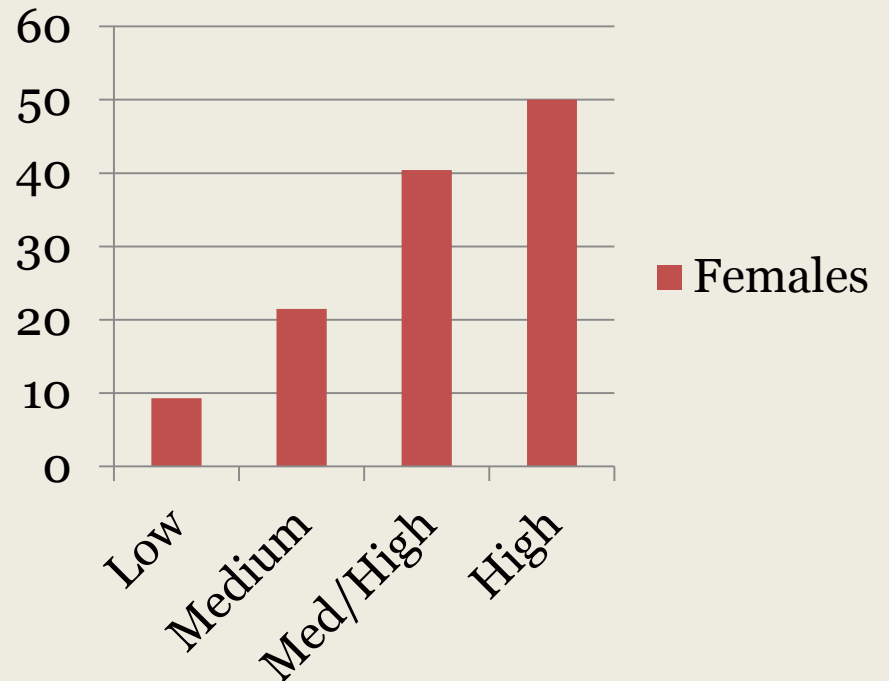


Risk Level By Recidivism

- **Conducting the Assessment**
 - File review
 - Self-Report
 - Interview
 - Scoring out
- **Post Assessment**
 - Review results with client
 - Begin building case plan based off assessment with client input
